Special Hazard Incomplete combustion and thermolysis may produce gases of varying toxicity such as carbon monoxide, carbon dioxide, various hydrocarbons, aldehydes and soot. These may be highly dangerous if inhaled in confined spaces or at high concentration. The potential danger appears only after the evaporation of the water in the product, i.e. during fire or after accidental projection of the product on a very hot surface.
